ACTIVITY RELEASE OF LIABILITY

READ CAREFULLY – THIS AFFECTS YOUR LEGAL RIGHTS

In exchange for participation in the activity of the Inflatable Bouncy House organized by Creative Learning Center, of 2100 Woods Lane, Los Altos, California, 94024. I hereby consent and agree for my son/daughter, to the following:

1. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by the employees, representatives or agents of Creative Learning Center.
2. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and my family members, and further release and discharge Creative Learning Center for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Creative Learning Center, whether caused by the fault of myself, my family, or other third parties.
3. I agree to indemnify and defend against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the Bouncy House and facilities of Creative Learning Center.

I consent to the participation of my son/daughter, (**student's name**) _____ of 2100 Woods Lane, Los Altos, California, 94024 in Inflatable Bouncy House, and agree on behalf of the above minor to all of the terms and conditions of this Agreement. By signing this Release of Liability, I represent that I have legal authority over and custody of (**student's name**) _____

In the event of injury to the above minor during the above described activities, I give my permission to the employees, representatives or agents of Creative Learning Center to arrange for all necessary medical treatment for which I shall be financially responsible. This temporary authority in relation to the Inflatable Bouncy House will begin on upon enrollment _____ and will remain in effect until terminated in writing by the undersigned or until the end of the enrollment at Foothill Preschool. Creative Learning Center shall have the following powers:
 1. The power to seek appropriate medical treatment or attention on behalf of my child as may be required by the circumstances, including without limitation, that of a licensed medical physician and/or hospital;
 2. The power to authorize medical treatment or medical procedures in an emergency situation; and
 3. The power to make appropriate decisions regarding clothing, bodily nourishment and shelter.
6. Any legal or equitable claim that may arise from participation in the above shall be resolved under California law.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT. I FURTHER UNDERSTAND THAT BY SIGNING THIS RELEASE, I VOLUNTARILY SURRENDER CERTAIN LEGAL RIGHTS.
